IN FISCAL YEAR 2015, SUNCOAST COMMUNITIES BLOOD BANK COLLECTED 34,447 UNITS OF ALLOGENIC RED BLOOD CELLS AND 4,193 PLATELETS FROM 18,000 DONORS. OVER THE COURSE OF THE YEAR, SUNCOAST COMMUNITIES BLOOD BANK SUPPLIED OVER 39,058 BLOOD PRODUCTS TO THE PATIENTS IN OUR LOCAL HOSPITALS. THIRTEEN TESTS (11 FOR INFECTIOUS DISEASES) ARE PERFORMED ON EACH UNIT OF DONATED BLOOD PRODUCTS.

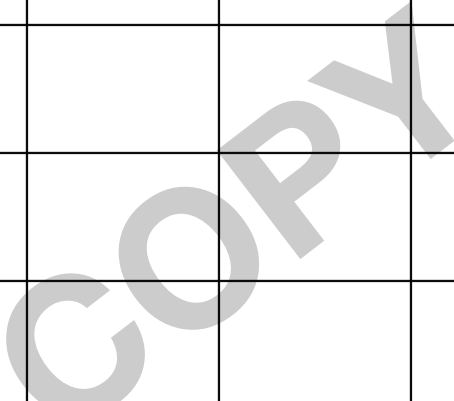

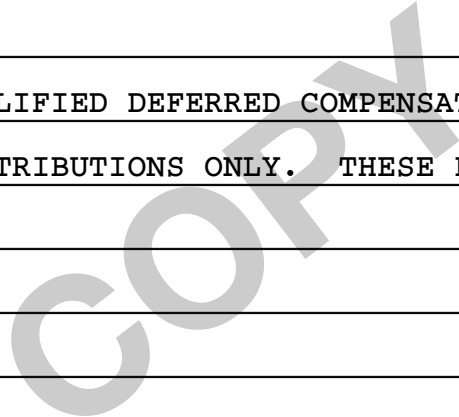

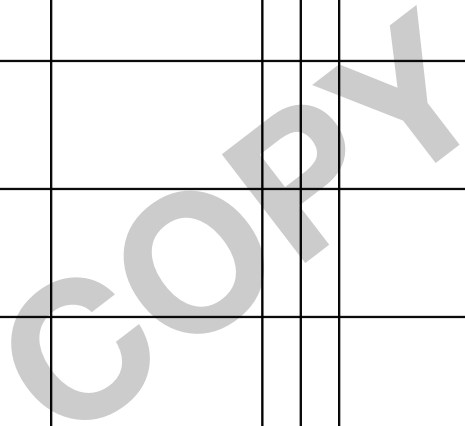
